# **Privacy Policy**

# Change

#### Use of Information

We may use your information for the purposes of:

## Sharing of Information

We may share your information with:

- (b) law enforcement agencies to comply with law enforcement requirements.

It goes without saying that we and the third parties with whom we share information will strictly abide by Google's rules on user privacy.

### Retention of Information

We will only retain your information as long as it is necessary for the purpose of your application and to achieve the purpose of using the information described in this policy. When the prerequisites for retaining the information mentioned above disappear, we will delete your information from our servers or anonymize it to ensure that we cannot identify you.

#### Protection of Information

We have taken necessary information security measures to ensure that only authorized personnel have access to user information to protect user information from loss, abuse, change or destruction. These authorized personnel have also signed relevant confidentiality commitments.
