Dear Fitchburg Public Schools Families,

Fitchburg Public Schools are places of learning, and our primary focus is on the education and well-being of our students. While we are aware of discussions and reports surrounding the U.S. Immigration and Customs Enforcement (ICE) operations, our district's approach will continue to prioritize the safety and sense of security of our school community.

In light of recent developments concerning ICE activities, I want to reaffirm our district's unwavering commitment to the safety and well-being of all our students and their families.

When it comes to our students and families' immigration status, please know that Fitchburg Public Schools maintains the following protections:

- FPS does not collect or maintain information relating to the immigration status of students or their families.
- FPS does not coordinate with Immigration and Customs Enforcement (ICE).
- FPS does not share student records with ICE, except in rare instances when a court order or parental/guardian consent is provided.
- FPS will not allow ICE access to our schools without a criminal judicial warrant signed by a federal judge.
- FPS only dismisses students to people authorized by parents/guardians. We ask that all families make sure their child's information is up to date with your child's school.

Principals and school staff have received information on protecting students' rights, responding to ICE interactions, and supporting students whose parents/quardians may be detained.

The Massachusetts Department of Elementary and Secondary Education (DESE) is working with the State Office of Refugees and Immigrants to provide districts with further guidance and information. On Monday, January 27th, the DESE will provide school districts with an overview of legal resources for immigrants in the Commonwealth, know your rights resources, and guidance for interaction with immigration officers. I will reach out to all families next week with additional information.

We encourage families to stay informed and reach out with any concerns or questions. Our counselors and support staff are available to provide assistance and resources as needed. Together, we will continue to foster an inclusive and supportive educational environment for all students.
