Number of break ins near Jefferson/Beville- alley lights are usually private pay, not provided by the city. If there is an IPL- and a number it's from the electric company, if there is just a hyphen and number it's probably private pay.

Illegal dumping- the city will come out twice a year to clean that up if that happens to someone's lawn if the property owner calls it in. City will also provide no dumping signs if there is an area that happens routinely. Metropolitan development department handles this.
