1. Introduction

- **Document Information:** Details about the Google Docs you convert, including content and linked documents (converted into images).

3. How We Use Your Information

- **Provide and Maintain the Add-On:** To convert your Google Docs into PDFs, embed linked documents as images, save them to your Google Drive, and email copies to you.
- **Account Management:** To manage your subscription, including billing and providing customer support.
- **Improve Our Services:** To analyze usage patterns and improve the functionality and user experience of the Add-On.
- **Communication:** To send you important updates, promotional materials (if you opt-in), and respond to your inquiries.

4. Sharing Your Information
