The Citizens Bond Oversight Committee (CBOC) is a group of volunteers who review and report on the expenditures of taxpayer money for school construction.

The District is currently looking to fill positions on the committee such as: parent/guardian, senior citizens organization member, taxpayers association and business organization members (see member criteria below).

Background:

Voters in the Middletown Unified School District (District) approved Measure "H" on Tuesday, November 6, 2018. Measure "H", a \$28 million bond measure, was put on the ballot to renovate and improve Middletown schools, including improved libraries, classrooms, roofing, HVAC, technology, a new gym and cafeteria, and solar energy systems.

The District is in the process of recruiting individuals to serve on the Citizens' Oversight Committee for Measure "H".

The committee shall consist of at least seven (7) members appointed by the Board and must meet the following criteria:

- One (1) member shall be the parent/guardian of a child enrolled in the District
- One (1) member shall be both a parent/guardian of a child enrolled in the District and active in a parent-teach organization
- One (1) member active in a business organization representing the business community located in the District
- One (1) member active in a senior citizens' organization
- One (1) member active in a bona fide taxpayers association
- Two (2) members of the community-at-large
