

# Life & Health License Renewal Guide

**Step 1:** Check your resident state's requirements—how many CE hours are required, how many you've already completed, and how many hours you still need before renewing your license.

1. Login [www.successce.com](http://www.successce.com), then click the “statement requirement” on the left side.

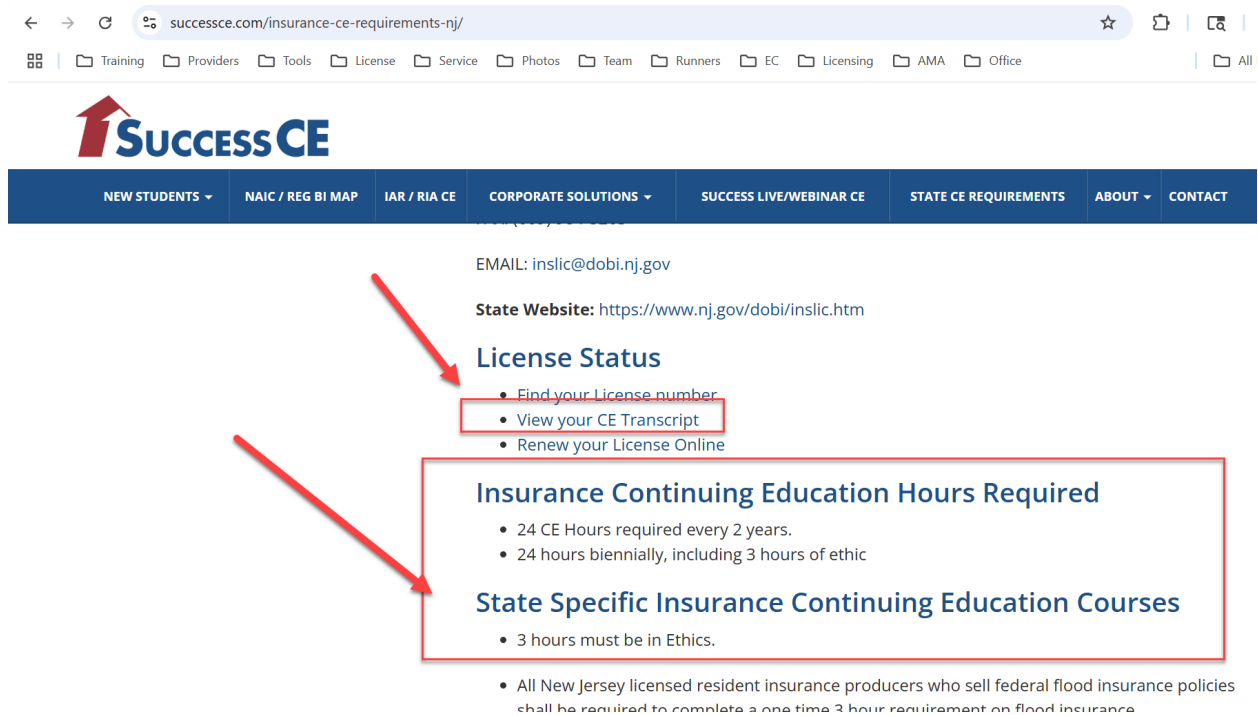

- Click on “**View Your CE Transcript**” to see how many CE hours you’ve already earned and how many you still need to complete before renewing your license.


