We have received word from the Halton Crown and the HRPS requesting that if counsel get a judge's order to bring a matter into Halton that it is imperative to give the crown and the HRPS a heads up so that they can get the file pushed from the police to the crown. Absent this they cannot guarantee that the matter can be spoken to in a meaningful way on the day of the return of the judge's order.

Surety Protocol

All sureties are to attend via videoconference. Counsel are to check identification using a selfie with the proposed sureties ID visible. A separate pic of the ID should be acquired in case there is any issue on the police check.

**SPECIAL BAILS are being conducted on the regular bail list for the time being. It should be noted that consents will be given priority over contested hearings.

Bail Variations

Bail variation requests should go through the vertical file crown. If that person is unknown then request through John.Dibski@ontario.ca as he is the bail vettig crown be prepared to be forwarded to the vertical file crown.

WASH Court

Wash court for Milton is held in Hamilton and the protocol for Hamilton is used.

Disclosure Protocol

Disclosure is still being vetted and distributed. Contact with the vertical file crown is the best. The crown office is open for pick up from 10am-12pm and 2pm-4pm weekdays.

They have been trying to send some disclosure electronically but are not able to send videos etc.

CPT/JPT Protocol

It is important for JPTs that you have provided a phone number that you can be reached at as the judge conducting the JPT will call counsel rather than using a conference line. You can provide your number through the trial coordinator:

Currently scheduled in-custody Judicial Pre-trials:

- Will proceed as scheduled by teleconference.
- New in-custody judicial pretrials are to be set through the trial coordinator by sending a joint email request, from crown and defence, setting out the details of the case and contact numbers for both parties.
- Following the judicial pretrial, the defendant will be adjourned to a date agreed upon by the parties. Counsel may address the matter, by teleconference, on the record, after the judicial pretrial is completed.

Currently scheduled out-of-custody Judicial Pretrials:

- Will proceed as scheduled by teleconference.
- Counsel for both parties are requested to provide a contact number to the trial coordinator.
- If the matter is set for 10:00 am, counsel will be called between 10:00-11:30. If it is set for 11:30, between 11:30-1:00, and if set for 2:00, between 2:00-3:30.
- Following the judicial pretrial, the matter will be presumptively adjourned, to be spoken to, with a warrant with discretion. New out of custody trial dates will not be set prior to the end of the presumptive adjournment period, unless the judicial pretrial judge directs otherwise.

Please do not attend in person or have the defendant attend.

Future out of custody Judicial Pre-trials:

- New out of custody judicial pre-trials are to be set through the trial coordinator by sending a joint email request, from crown and defence, setting out the details and contact numbers for both parties. Additional time slots will be added on Monday, Tuesday and Wednesday, of each week, to commence April 1.
- Counsel will be provided an appointment time for the judicial pretrial.
- Following the judicial pretrial, the matter will be presumptively adjourned, to be spoken to, with a warrant with discretion. New out of custody trial dates will not be set prior to the end of the presumptive adjournment period, unless the judicial pretrial judge directs otherwise.
- Please do not attend in person or have the defendant attend

<u>Beginning Monday September 28, 2020</u>, counsel and accused persons who are out of custody will be able to attend for duty court/plea court in Milton by videoconference or audioconference (telephone) using Zoom.

The out of custody list will commence at 10 am. If a matter cannot be reached before 11 am, when in custody matters begin, the parties will be given a call-back time.

In custody matters may also proceed by Zoom but must be scheduled in advance, through the trial coordinator. Alternatively, they may proceed by audioconference.
