- 1. Information we collect and permissions required

- 1.1 When you use this application, we will not collect any information about your use, and all the data you use will be kept in the local disk.
- 1.2 When you use our applications, in order to ensure your normal use, maintain the normal operation of our services, improve and optimize user experience and protect your account security, we may require you to grant the following personal permissions to use you:
- 1) Storage permission: read and modify the content in the SDK;
- 2) Network permissions: get network data;
- 3) TrueDepth cameras and sensors to track and provide augmented reality ("AR") capabilities. Any data, images and videos captured by the camera are processed locally and deleted immediately after processing, never leaving your device or sharing with any third party.
- 2. How we use, transfer and disclose your personal information
- 2.1 The information we collect will be used for the following purposes:

- 2.1.1 We will only use your information to implement the functions of this product or service and provide you with services as described in this policy;
- 2.1.2 To meet your personalized needs and provide you with personalized suggestions and services, such as recommending content that is suitable for you or may be of interest to you based on your browsing, searching and other behaviors;
- 2.1.3 To optimize products and services, improve user experience, conduct data statistics and analysis to evaluate, maintain and improve the performance of our products and services, develop new products, new services, provide customer support, etc., will be de-identified in the following cases use, which does not personally identify you;
