## INTRODUCTION [ARIAL 11PT, BOLD, BEFORE 9PT, UPPERCASE]

Introduction is written in **Times New Roman 12pt, 1 line spacing, before 9pt**. Words in a foreign languages are in italics form. The IJAP journal will publish scientific papers in the field of Physics. This can take the form of dissemination of research results, comprehensive scientific literature reviews, or reviews of scientific books <sup>[1-2]</sup>.

In general, the manuscript should contain an abstract, an introduction, research objectives, and methods, discussion, conclusions, acknowledgments (if any), and literature/references [1],[3]. The introductory part of the manuscript should provide the background of research/scientific writing, a literature review providing an introduction to the problem, the update of the article on the literature review, and the research purpose.

The content is in the form of a review, a review of all scientific literature, or a review of a scientific book does not have to include the methods [4]. To cite the bibliography, it is recommended to use *Mendeley* in the following format:



The results cannot be separated from the discussion thoroughly and continuously. In presenting data in tabular form, use a format of Table 1. If there are multiple tables, use numbering such as Table 1, Table 2, etc.

• Table is created with a line width of 1pt and a *table caption* is placed above. Descriptions that consist of more than 2 lines are written using 1 space. Table lines are prioritized for horizontal lines only, while vertical lines are omitted. Each table should be "called out" in the text and given a discussion explaining the contents of the table.

**Figure 1.** Figure descriptions (more than 1 line) are adjusted to the length of the figure (Times New Roman 10, after & before 9pt, Justify)




Figure 2. Figure caption in 1 line (Times New Roman 10, after & before 9pt, Center)

Acknowledgments are written in **Times New Roman 12pt, 1 line spacing, before 9pt**. The author expresses profound gratitude to the funder of the activity (if there is a contract number, it can be included and the year of acquisition). Furthermore, it can also be addressed to parties who play an important role in discussions, data collection, or analysis that are directly related to the research presented.

## REFERENCES [ARIAL 11pt, Bold, Before 9pt, UPPERCASE]

Reference is written in **Times New Roman 11pt, 1 line spacing** using a reference management application (such as Mendeley, Endnote, Zotero, and others) with the American Psychological Association (APA) system. Only the related references in the text are listed in the bibliography. Minimum of 15 references provided that 80% are from primary sources and from the last 10 years.
