Salesh ("Sal") Prasad is a beloved nephew, uncle, brother, artist and LGBT community member from Modesto, California. Sal is at risk of being deported to Fiji, a country he left over 44 years ago.

UPDATE: On April 27th, an immigration judge granted Sal relief under the Convention Against Torture (CAT). His deportation is prevented for now, however ICE has a chance to appeal. While he is now safe from deportation, a Governor's pardon would offer Sal an opportunity to be recognized for his full humanity. See below on how you can get involved!

Background: Sal came to the U.S. as a Lawful Permanent Resident at the age of 6. He served 27 years in prison for a conviction at the age of 22. He was found eligible for release from prison due to his rehabilitation and remorse. However, in August 2021, after being found eligible for parole, instead of being released to the community, he was directly transferred from prison to ICE Custody at Golden State Annex. Shortly after he was detained by ICE, his mother passed away from COVID, and ICE denied him the opportunity



to be released, even temporarily, to say goodbye or to attend her funeral. As a child, Sal experienced domestic violence within his household, and was sexually abused by an adult male acquaintance. The abuse pushed him to seek protection from gang members, and to self-medicate with drugs and alcohol. Sal took a person's life at age 22 during an altercation. He is incredibly remorseful for this and understands the impact of his actions.

Sal is now 51 years old. While incarcerated, Sal focused on healing, rehabilitation, and change. He has healed from the abuse that he suffered through therapy and through reflecting on the transition he has made from victim to survivor. He reflected on the harm that he had caused and the incredible remorse he holds. He became a leader in prison and strives to help others who are incarcerated in order to fulfill his goal in life to help people rather than hurt them. Sal's personal growth, community service, and strong ties to the community since his incarceration clearly demonstrate the efforts he has made to rebuild his life and give back to others.

Sal is not alone. ICE and CA prisons and jails have a history of targeting, detaining, and deporting community members *after* they have served time and have earned release. In addition to advocating for the

release of Sal and other community members, we must end the ongoing collaboration between ICE and our prisons and jails!

In early December, an Immigration Judge concluded that Sal does not pose a danger or a flight risk, and granted him release on bond. If deported to Fiji, Sal would be at risk of discrimination due to his Queer identity. His family and support system is here in the United States. I urge Gov. Newsom to pardon Salesh immediately and bring him home." "
