

User Agreement with Kitchen Life Transformation, LLC

IMPORTANT: Please read carefully. BY PURCHASING THE FIRST MONTH'S MEMBERSHIP IN THE STRESS-FREE DINNER CLUB (Program), as well as by ACCESSING OR USING THE CONTENT WITHIN THE PROGRAM, YOU ACKNOWLEDGE THAT

A. YOU HAVE READ THIS AGREEMENT,

B. YOU UNDERSTAND IT, AND

C. THAT YOU ACCEPT AND AGREE TO BE BOUND BY ITS TERMS.

WHEREAS, Kitchen Life Transformation is engaged in the business of client coaching services; and WHEREAS, YOU desire to engage Kitchen Life Transformation to provide kitchen and meal planning coaching services to YOU in the form of audio, video, and/or visual presentations and periodic group coaching;

NOW, THEREFORE, the Parties agree as follows:

SECTION 1: Membership and Program Fees

- 1. Program: Under the terms of this Agreement, Kitchen Life Transformation agrees to provide meal planning coaching services to YOU in the form of audio, video, and/or visual presentations and periodic group coaching in the Program called The Stress-Free Dinner Club ("Program") in exchange for a Program Fee. Program Fees will be determined according to paragraph 4. below. Your access to such Program is made conditional on payment of such Program Fee.
- 2. Term: The Term of this Agreement will commence upon YOUR payment of the initial monthly fee determined according to paragraph 4 of this Agreement. YOU agree and understand that upon commencement of your membership through this initial payment, YOU will become enrolled in the Program on a month-to-month basis beginning on the day of the initial payment.
- 3. Termination: Kitchen Life Transformation may terminate this Agreement at any time in its discretion upon notice to YOU. Section 3 below shall survive termination of this Agreement, binding YOU to Confidentiality in perpetuity.



- 4. Program Fees: By accepting the terms of this Agreement, YOU agree and understand that you are committing to pay Kitchen Life Transformation monthly payments of \$47. YOU can cancel any time with written notice to Kitchen Life Transformation at kare@kitchenlifetransformation.com. Kitchen Life Transformation will cancel your membership within seven business days.
- 5. No Refunds: Kitchen Life Transformation abides by a strict, no-refund policy. By accepting the terms of this Agreement, YOU agree and understand that you are foregoing the right to claim any refund of fees paid for access and use of the Program offered by Kitchen Life Transformation.

YOU further acknowledge that in accepting the terms of this Agreement and affirmatively seeking the benefits of and membership in such Program, YOU are taking full responsibility for YOUR OWN success. Thus, YOU agree that you will not request a refund.

SECTION 2: NO WARRANTIES

- 1. All content, information, products and/or services in the program are an "as is" and "as available" basis without any representations or warranties of any kind including the warranties of merchantability or fitness for any purpose, express or implied, to the full extent permissible by law. Kitchen Life Transformation makes no representation or warranties as to the content, information, materials, products, and/or services provided in the program. Kitchen Life Transformation makes no warranties that the program will perform or operate to meet your requirements or that the information presented with be complete, current, or error-free. Kitchen Life Transformation disclaims all warranties, implied and express, for any purpose to the full extent permitted by law.
- 2. Success not Guaranteed: By accepting the terms of this Agreement, YOU agree and understand that Kitchen Life Transformation provides the Program related to kitchen and meal planning coaching only and guarantees no specific results. YOU take full responsibility for YOUR own success.
- 3. Content of the program: Kitchen Life Transformation does not represent itself as providing services equivalent in any way to a nutritionist, dietitian, or medical/nutrition professional of any kind. The recipes, meal plans, and use of ingredients provided are not prescriptive in a health, wellness, medical, or nutrition capacity. By accepting the terms of this Agreement, YOU understand and agree that YOU will contact your own doctor should YOU have questions about changing the types of food YOU eat or methods by which those foods are cooked/prepared. YOU also understand and agree that it is your responsibility to be aware of signs of spoilage, undercooked food, and other food safety guidelines for your safety. 4. SECTION 3: Confidentiality

- 1. Confidentiality: Only authorized users, who have duly attained access to the Program offered by Kitchen Life Transformation by personally agreeing to the terms of this Agreement are permitted use and participate with such Program. SECTION 4: Mediation and Arbitration

Any dispute between the Parties under this Agreement shall be first submitted to mediation and then if still unresolved to binding arbitration. Said mediation or binding arbitration shall comply with and be governed by the provisions of the laws of the State of North Carolina unless the Parties stipulate otherwise.

SECTION 5: Miscellaneous

- 1. Non transferability: The rights and obligations under this Agreement are personal to YOU. YOU may not assign or transfer any rights or obligations under this Agreement.
- 2. Indemnification: YOU will, at your own expense, defend, indemnify, and hold Kitchen Life Transformation, its agents, and employees harmless from any and all claims, actions, liabilities, injuries, damages, losses, grants, costs, and expenses, including attorney fees, arising out of or in connection with any use of the Program of this Agreement.
- 3. Integration: This Agreement, along with any additional terms or policies incorporated herein by reference, represents the entire Agreement between YOU and Kitchen Life Transformation concerning the Program, and this Agreement supersedes and replaces any prior proposal, representation, or understanding YOU may have had with Kitchen Life Transformation relating to the Program, whether oral or written.
- 4. Amendment: Kitchen Life Transformation reserves the right, in its sole discretion, to amend this Agreement in writing by giving notice to YOU.

Governing law: This Agreement shall be governed by and interpreted in all respects in accordance with the laws of the United States of America and the State of North Carolina.
