Academic Excellence: Centennial Academy will achieve and sustain top-tier academic results by outperforming the district and state average, ultimately achieving a score of 90 or above, as measured by the College and Career Readiness Performance Index (CCRPI)

22-23 Target Goal: Scholars will demonstrate a 20% increase in ELA and Math proficiency as measured by iReady diagnostic data by the end of the academic year. We will achieve a 20% increase in the number of students meeting their growth goals in ELA and Math as indicated by iReady Math Target: 48% ELA Target: 58%. **In Progress**

Updates:

- The TSI designation is assigned to any school in the state of Georgia with at least one subgroup performing in the lowest 5% of all schools in at least 50% of CCRPI components.
- For Centennial, our students with disabilities subgroup met these criteria, based on 21-22 GMAS test scores and CCRPI data.
- A school **exits** from TSI if no subgroup performs in the lowest 5% of all schools in at least 50% of CCRPI components.
- Progress Learning has begun at every grade level
- Winter iReady diagnostic scheduled for December (more data to discuss in January)
- Continue to have conversations with APS about a clear pathway for charter renewal; application opens in January.
- GCSA is supporting the charter renewal process.
- Charter renewal committee will be formed during the month of December.
- Funds will be utilized in the upcoming months for charter writers and consultants.

School Culture: Centennial Academy will achieve high satisfaction among stakeholders by ensuring a safe, supportive, and inclusive environment for every scholar, educator, and parent as indicated by 4 out of 5 stars on the CCRPI School Climate Star Rating

22-23 Target Goal: 83% of scholars will attend 90% of enrolled days by the end of the academic year. **Not on Track**

Updates:

- Staff vaccine clinic completed (still waiting on exact numbers of shots given)
- 66.4 CCRPI attendance data calculation; 66% of CPA scholars; 70% of transitional scholars

- Attendance team is working to remove barriers for parents; data is being tracked so that we can strategically respond
- Other attendance interventions: targeted intervention list; monthly attendance team meeting; attendance letters with retention language
- Communities in Schools representative on campus. Our liaison has a targeted list of chronically absent students
- Fridays continue to track below Monday through Thursday attendance (early dismissal)
- Bus services continue to be a struggle. We have taken action and seen some improvement but is very inconsistent. Looking for 23-24 solutions. (impacts attendance and parent satisfaction).
- Working with APS for creative solutions for food service. This is an issue across the district.

Professional Capacity: Centennial Academy will achieve 90% retention among staff by fostering a positive and healthy working environment that retains, supports, rewards, and attracts talented educators

22-23 Target Goal: 85% of staff will be retained by the end of the academic year. **Not on track**

- Thankful for teachers week was well received; culminated with a Coca-Cola sponsoring a teacher appreciation luncheon on Nov. 18 (live music and catered lunch)
- No resignations over the Thanksgiving Break
