1. Introduction

In this privacy notice, we describe our privacy policy. We seek to explain to you in the clearest way possible what information we collect, how we use it, and what rights you have about it. 2. Information We Collect

We collect personal information that you voluntarily provide to us when registering at the Site, expressing an interest in obtaining information about us or our products and services, participating in activities on the Site, or otherwise contacting us.

3. How We Use Your Information

We use personal information collected via our Site for a variety of business purposes described below. ("Legal Reasons"). We indicate the specific processing grounds we rely on next to each purpose listed below:

To fulfill and manage your orders for Contractual reasons.

To manage user accounts for Business Purposes and/or for Contractual reasons.

To deliver services to the user for Business Purposes, Contractual reasons, and/or with your Consent.

To respond to user inquiries/offer support to users for Business Purposes, Contractual reasons, and/or Legal Reasons.

4. Sharing Your Information

We only share and disclose your information in the following situations:

Compliance with Laws. We may disclose your information where we are legally required to do so to comply with applicable law, governmental requests, a judicial proceeding, court order, or legal process, such as in response to a court order or a subpoena (including in response to public authorities to meet national security or law enforcement requirements).

Vital Interests and Legal Rights. We may disclose your information where we believe it is necessary to investigate, prevent, or take action regarding potential violations of our policies, suspected fraud, situations involving potential threats to the safety of any person and illegal activities, or as evidence in litigation in which we are involved.

Vendors, Consultants, and Other Third-Party Service Providers. We may share your data with third-party vendors, service providers, contractors, or agents who perform services for us or on our behalf and require access to such information to do that work. Examples include payment processing, data analysis, email delivery, hosting services, customer service, and marketing efforts.

5. Data Retention

We will only keep your personal information for as long as it is necessary for the purposes set out in this privacy notice, unless a longer retention period is required or permitted by law (such as tax, accounting, or other legal requirements). No purpose in this notice will require us to keep your personal information for longer than 30 days.

6. Your Data Protection Rights

Depending on your location, you may have the following rights regarding your data:

The right to access – You have the right to request copies of your data.

The right to rectification – You have the right to request that we correct any information you believe is inaccurate. You also have the right to request that we complete information you believe is incomplete.

The right to erasure – You have the right to request that we erase your data, under certain conditions.

The right to restrict processing – You have the right to request that we restrict the processing of your data, under certain conditions.

The right to object to processing – You have the right to object to our processing of your data, under certain conditions.

The right to data portability – You have the right to request that we transfer the data that we have collected to another organization, or directly to you, under certain conditions.
