June 27, 2023 Meeting Minutes Approval: Chrissy made a motion to approve the minutes. Tierney seconded. All approved. One noted change is that Yolanda Draine has accepted a job out of town and will not be joining the Veritas Governing Board.

### **Executive Director Report:**

- Enrollment: 135 scholars (44 6<sup>th</sup> graders, 48 7<sup>th</sup> graders, 43 8<sup>th</sup> graders) with several others planning to enroll which will push the total close to 150 scholars
- 2023-2024 Updates
  - o Teacher In-service, July 24-August 4
  - CodeCrew, Clean Memphis, VAF Fitness, Grizz Fit, and Bridge Builders are elective/extracurricular partners
  - o Athletic offerings will include wrestling, basketball, track, and possibly other sports
  - An updated school app was launched and a new teacher-family communication portal was added to enhance communication with families
  - 20-25 former VCP graduates have expressed interest in volunteering in some capacity at the school
- 2023-2024 Staff
  - o Fully staffed with 19 full-time team members and one part-time team member
  - Added a Dean of Instruction and an additional Interventionist

### Financial Report:

- Net Worth: ~\$819k (Includes \$762k in Operating Account; \$50K Reserve Account; \$20K Student Rewards Account; \$13,281 in total debt
- Estimated TISA payment of \$150,990 expected between August 18-21
- Utilized all but \$3,600 of ESSER 2.0 funds. The budgeted amount for ESSER 3.0 in the FY24 budget is \$834k and expires June 30, 2024. Spending priorities include staffing, IT support services, curriculum software, updated family communication via the school app, and student elective partnerships

#### 2023-2024 Board Chair:

 Chrissy nominated Tierney Jackson Smith as Board Chair. Liz seconded the motion. All approved.

### New Board Member:

• Tierney nominated Derek King to a position on the Veritas Governing Board. Lara seconded the motion. All approved.

# Review of Faculty Survey:

 Tierney gave an overview of the survey results. Nick reported that many of the items were addressed in the Teacher in-service time before the school year including the addition of a substitute service to address covering for faculty who are absent and discussion regarding discipline policies

## Other Business:

- Matt Weathersby has registered the board for board training via the TN Charter Center but has not yet received feedback with the course schedule and links.
- Matt Weathersby requested board members to send their preferred committee assignments for the upcoming school year. Committees are Academic Oversight, Finance, Governance-Development and Governance-Operations
