#### **Dress Code**

Students are not required to wear the Crossroads uniform. They are, however, expected to adhere to common practices of modesty, cleanliness and neatness; to dress in a respectful manner within the acceptable standards of the community. The uniform guidelines are below:

#### **SHIRTS:**

- Black button down dress shirts and/or polo shirts are acceptable. These can be short or long sleeves.
- Crop tops, tube tops, halters and spaghetti straps are unacceptable (anything less than 2 inches is considered a spaghetti strap.)
- Low cut blouses, tops, sweaters, etc. with plunging necklines are not allowed.
- Transparent and/or see through material is considered unacceptable. Shirts/tops must touch the waist of pants/shirts at all times (i.e. when in movement, when arms are extended or raised, and when in seated positions, etc.)

#### **PANTS:**

- Khaki or black pants should be worn. No shorts, skirts or skorts are acceptable.
- Intentionally torn or cut/ripped up pants that are considered indecent exposure are inappropriate.
- Form-fitting garments such as spandex, tights, leggings, etc. may only be worn with another layer of clothing over top, which meets the dress code.
- Pajamas and flannel pants are inappropriate.

#### **GYM UNIFORM:**

- Black sweatpants
- Black or grey t-shirt and/or black sweatshirt
- Sneakers

#### OTHER UNIFORM RESTRICTIONS

- Any clothing, accessories, symbols, jewelry, or other paraphernalia, which depicts or suggests association with a gang or inappropriate language or symbolism, shall not be brought to school, worn at school, or in any way be present at any school-sponsored event.
- Flip Flops, slides, or slippers are NOT acceptable. Students MUST wear shoes that have back support.
- Hoodies, scarves, du rags, bonnets, ski masks and hats are NOT acceptable to wear in the building. Lockers are available for these items.

## **Attendance Policy**

Students are expected to attend school daily to promote and ensure academic progress. Hours of school attendance are: 8:00 am – 2:30 pm.

If you absolutely have to be out, be sure to have your parent or guardian call 215-400-9070 or email <a href="mailto:thudson@philasd.org">thudson@philasd.org</a>, the main office before 9:00 am to inform the school of your absence. On the day following your absence, please bring a note to the main office from your parent or guardian explaining why you were out. The District considers the following conditions to constitute reasonable cause for absence from school:

- Illness
- Quarantine
- Recovery from accident
- Required court attendance
- Death in family
- Educational tours and trips, with prior approval.
- Authorized school activities

In the event that a note is not provided the absence will be marked as "UNEXCUSED." All legitimate absences will be "EXCUSED" for attendance records. Chronic absences will be automatically reported as truant. Finally, be sure to make arrangements to complete the work you missed.

#### Lateness

School begins at 8:00am. Students who arrive at school after 8:15 am are considered late. Students are excused if they have an appropriate note from a parent and/or guardian or a medical provider. Students are unexcused without an appropriate note.

## **Early Dismissal**

In an attempt to maintain the integrity of the educational program, it is necessary to keep early and irregular dismissals to a minimum. Students are required to submit early

dismissal notes with a valid phone number for verification to the main office upon arrival. Students will not be permitted to call from the main office for an early dismissal.

Any person picking up a student must have a proper photo ID. Please be sure to visit the office first, present your identification, and sign the Early Dismissal sign-out book. All early releases will be dismissed from the main office. You may not go to your child's classroom with the intent of taking them out of school.

Please Note: Only the parent/ guardian listed on the School District network is permitted to request early dismissals. **Students are not dismissed on their own**; a parent and/or emergency contact must arrive to pick up students and sign them out for the early dismissal.

#### Meals

Breakfast is served daily from 8:00 – 8:15 am. Please arrive during that time in order to be able to receive and eat breakfast. All students are provided with free breakfast and lunch.

- Students may NOT bring any outside food or drink.
- Empty water bottles may be brought in to use with the water fountains.

## **Transportation**

The School District transportation department will determine the student's eligibility for the Septa Fare Card. Students' addresses must be 1.5 miles or more from Crossroads to be eligible for a Fare Card. This process will take approximately 48 hours from the time the student is registered to Crossroads Accelerated Academy.

Students will receive their fare cards as soon as the School District transportation office determines their eligibility. They are to keep these cards for the **ENTIRE SCHOOL YEAR**. Student Fare Cards are active 5:30 am - 8:00 pm only on days school is in session. If you lose your card, contact Mr. Angelini . Your old card will be deactivated and you will be issued a new card.

#### Student ID's

Students will receive a photo ID that they will need to wear to school *everyday*. This ID is really important. This ID is attached to a system called ScholarChip. Scholar Chip is the School District of Philadelphia's program that we will use to track daily attendance. Every morning, there will be a scanner in front of the door. All students have to do is place their ID in front of the scanner, and it will mark them present.

#### Fees for IDs

Each student will be provided with a student Id free of cost for the first card. They will also receive a lanyard and card holder. Students should keep their ID inside the card holder for protection. If a student's card is damaged, it will not work. Your student will have to pay a fee \$5 to replace the card and \$1 to replace the lanyard and card holder. Losing an ID card will also delay the line during entrance. If a student leaves their ID at home, a staff member has to punch in their student ID number. Each time a staff member has to punch in their ID number, they are charged \$1 to their student account which will have to be paid prior to receiving their program completion certificate.

## **Visitor Screening Procedures**

- Guests should go through security monitors and sign in at the front entrance with school police.
- Guests will be prompted to share their purpose for visit and be prompted to report to the main office.
- Guests will sign into the main office on the visitors log with the secretary.
  - If a parent is picking up a student, they MUST show their ID and be listed as one of the student's contacts.
- Guests will exit through the main entrance and sign out with the school police officer.

#### **Communication with Families**

It is important that we keep open lines of communication with our families regarding happenings at Crossroads. The following are the ways in which we regularly disseminate information to our families:

- School Messenger (Automated School Phone Call System)
- Email
- Mail (If your address is not up to date, please bring an official document that shows proof of address to the main office and our secretary will update in our system)
- School Website

## **Celebrating Success**

#### **PBIS**

- Students earn PBIS points from teachers and staff for making positive behavior choices and upholding our school norms - Be Engaged, Academically focused, Respectful, and Self-disciplined.
- Students can redeem points at our school store or to attend monthly PBIS events. Past events have included trips, cookouts, movie events, and athletic competitions.

#### **On-Time Arrival Wheel**

- All students who enter the building by 8:15 earn spin on the prize wheel at lunch. The wheel includes items like snacks, drinks, extra credit passes, Crossroads gear and other prizes.

### **Monthly Attendance Challenges**

- We challenge all students to make 90% attendance. Each month there is a different incentive for students who meet that goal. Past incentives have included pancake breakfast, gift card raffle, ice cream social, water ice, open gym, "paint night", and other fun activities. Students should look for the attendance challenge signs posted at the beginning of each month describing the incentive and the number of days required to make 90%

#### **Grizzly Den**

- We are excited to launch our Grizzly Den game room this year. The game room has a mix of board games, arcade games, game systems, and other activities. Students can be invited to the Grizzly Den for meeting individual academic or behavioral milestones, as a whole class incentive, or for earning Grizz Status.

#### **Grizz Status**

- At Crossroads, we want to recognize students' efforts and growth in and out of the classroom. One way that we do that is through a bi-weekly Grizz Status recognition.
- Students who earn Grizz Status are recognized on the board and are invited to the Grizzly Den last period every Friday.

## Anti Bullying and CyberBullying

Crossroads Accelerated Academy does not tolerate bullying of any kind. Bullying and Cyberbullying is defined as "actions (or threats of action), either physical or verbal, which instill fear or which serve to demean an individual and are committed by a community member over a period of time." Bullying includes verbal and physical taunting or intimidation for any reason. Examples include, but are not limited to, race, religion, sexual orientation, disability, and so on. Bullying can occur in person, over the Internet (Twitter, Facebook, etc.), through cell phones, cameras, or video, or by any other means through which people can communicate or share information. Students and staff alike can be victimized. Bullying can occur regardless of the intentions of the bully/bullies; it is the perception of the victim that must be taken into consideration. Students who engage in bullying of any kind will be subject to consequences according to the School District of Philadelphia's <u>District Policy No. 249, Bullying/Cyberbullying</u> and <u>Student Code of Conduct</u>.

#### **Cell Phones**

Cell phones and ipads are not permitted at Crossroads Accelerated Academy. Students have the option of either leaving it at home or handing the phone in for the day. If a student/parent does not want the phone to be collected by school administration, the student should not bring the phone into the building.

- After arriving and passing through the scan, any student who is still in possession of his/her cell phone will turn it in at the entry for the day. Cell phones will be locked away securely and stored privately.
- All students will be given a bag with their name on it to put their phone in.
- Phones will be organized by cohort and distributed at the end of the day and will be given out to students as they leave the building.
- In the event a student has an authorized early dismissal, they should report to the main office to obtain the phone.
- If a student comes to school late, the phone will be placed in their cohort bin for pick up at dismissal

\*In the event that a phone is found in the building, the phone will be confiscated and a parent/ guardian must come to the school to pick it up. Continuous offenses may result in administration confiscating the phone until the end of the school year.

\*Administration is not responsible for any electronic device that is lost, stolen, damaged or confiscated

## **Acceptable Use Policy**

Crossroads Accelerated Academy values the use of technology and encourages its use in creative ways to support student learning in a safe and secure learning environment. This policy is a guide to ensuring the appropriate use as well as safety for all community members. While these technologies provide powerful learning opportunities, they must be used responsibly.

These rules apply to any electronic device including laptops, mobile, MP3 players, gaming devices, digital cameras, and any other devices that are connected to the School District of Philadelphia network. Learning always takes priority while using Crossroads's wireless and hardwired internet connections.

The following guidelines are in addition to the <u>School District of Philadelphia Acceptable</u>
<u>Use Policy</u>

## School Norms around the use of technology devices:

- Apple Watches are NOT to be utilized for texting or making phone calls.
- Do not touch another person's laptop/device unless invited by the owner.
- Do not play with, use, or change another person's user account.
- Do not access another person's files or resources.
- Only access areas of the network you have been given permission to access.
- Do not load any game, video or music file on your machine that is not paid for or that you do not have the rights to use.
- Do not access inappropriate websites (obscene, violent, etc.) on your laptop.
- Do not chat online or play music/videos unless given permission by your teacher.
- Do not post or send any message/picture/sound/video that is obscene, rude, harassing or insulting to anyone.
- Do not attack, threaten or intimidate another student via technology (or otherwise).
- Do not take pictures or post pictures of others without asking their permission.
- Do not download any illegal materials (e.g. cracked software, pirated music or movies, or any copyrighted materials) or intellectual property that was not purchased by you or that you do not have the rights to use.
- Peer to peer file sharing is strictly prohibited and monitored by the School District of Philadelphia these software programs can be detected by the District and they will shut off your access to the SDP Network.
- Do not plagiarize i.e. present anybody else's work as your own
- No spamming, hacking, hawking, or trolling.

- Do not forward or send any content not directly associated with your learning (e.g. advertisements, games, pictures).
- Do not deliberately or negligently spread viruses, malware, or spyware.
- Do not attempt to access any areas of the school network, or other peoples' devices you do not have permission to visit.
- Do not run a business or seek to make profit using the school network unless sanctioned by the school district.

#### Guidelines

- Crossroads Accelerated Academy and The School District of Philadelphia have the right to and will monitor user data and internet access and check the contents of any electronic device brought onto the school's premises or during any school event or function.
- Crossroads Accelerated Academy and The School District of Philadelphia have the right to monitor user data and internet access and check the contents of any electronic device that is the property of Crossroads Accelerated Academy or the School District of Philadelphia.
- This statement covers (but is not limited to) the use of electronic devices owned by the school and by students that are brought onto school's premises, or on excursions, camps or other official school functions - including computers, laptops, digital video and music players, cameras, other recording devices, mobile phones and organizers.
- Crossroads Accelerated Academy reserves the right to ensure all student laptops and online storage have sufficient space to support learning activities. This may include the school needing to delete non-essential games, music and video files.

#### **Laptop Audits**

• Audits of student laptops can be done by any staff member at any time.

#### Sanctions for violations stated above may include the following measures:

- Confiscation of the device for a defined period.
- Withdrawal of privileges including online access for breaches of online policy.
- Withdrawal of the right to bring or use electronic devices to Crossroads Accelerated Academy.
- Blockage from the network of any and all devices downloading illegal files such as music, video and photographs.
- Payment for the cost of repairs.

#### Responsibility

• Keep the computer in a safe, clean place.

- Notify Crossroads administration if the user changes residence at any point during the time they possess the laptop.
- Provide Crossroads administration and school police with a police report in the event of fire or theft of the laptop.
- Keep the laptop in a PADDED laptop case or backpack.

#### Serious Breaches of Rules

- All incidents will be handled on a student by student basis.
- Suspension or expulsion
- Law enforcement agencies may be involved.
- Simple finder will be installed on your computer which limits the applications on your laptop to strictly educational use.
- The laptops are the School District of Philadelphia's property. All users are responsible for caring for and properly maintaining their laptops. Any damage may result in a fee up to the replacement cost of the laptop (\$250).

#### File Storage

No personal files should be kept on the laptop, these must be saved to an external drive this includes all music files and photographs. Crossroads is not responsible for any lost school or personal files.

All students will be assigned a Google account by the School District of Philadelphia. This account includes online storage. This is for school files ONLY.

Students are responsible for maintaining the organization of their Google Drive - further instruction on doing so will be given in the technology course during the first week of school.

#### **Network - Connecting to the Internet**

The entire school is covered by a high-speed wireless internet network. All students will be able to access the internet, as long as they follow this policy. With this connection comes a degree of risk. This policy is made to help users avoid these risks, keep our community safe and abide by internet laws.

#### **Email**

Users will have access to an email account during the years they are at Crossroads . You may use this to communicate with parents, teachers, friends, experts and fellow students around the globe. An email address with the format <student ID>@philasd.org will be provided to all students. This address is to be used for all school-related business. Your private account should be used for all other communications. Users will have access to their other email accounts during "off" times during school, like lunch and free periods.

#### **Email/Chatting Etiquette**

Communicating online is very much like communicating with people in person. You must be respectful of others at all times. Remember that all email and virtual messages can be

read by the School District of Philadelphia. Don't write anything you would not want to share with teachers and parents.

Students are expected to bring their chromebook and charger to school daily. There are no additional chromebooks for loaned devices. If a student does not have their chromebook, they will miss out on accessing their assignments. Students are no longer allowed to bring in personal devices. They must use district chromebooks that are assigned to them.

## **Supplies**

Textbooks are supplied at no cost to the student, and remain the property of the School District of Philadelphia. Any School District property (ie: materials, computers, textbooks etc) that is defaced or lost must be paid for by the child to whom it was issued.

All outstanding debts must be paid prior to the student receiving his/her report card.

In addition to the supplies provided by the District, students will need to purchase the following supplies:

- Upon successful completion of the one-year accelerated program, students will begin 10<sup>th</sup> grade for the 2025- 2026 school year.

#### **End of Year Activities**

Participation in end of year activities is contingent upon academic success and compliance with the behavioral expectations at Crossroads Accelerated Academy.

The end of year activities include the Spirit of Philadelphia and the move up ceremony.

Dates for these activities will be provided at a later date. Students can be removed from participating in any of the end of year activities at any time.

#### **Dues**

All 8th and 9th grade students are required to pay dues for the end of year activities. If your child is unable to participate due to violation of the school's expectations, then money will be refunded. More information will be provided.

#### **Assessments**

All students are assessed utilizing STAR so that current reading and math levels can be captured. Students will be tested on their reading and math levels throughout the school year according to the School District calendar.

- 7<sup>th</sup> graders will take the PSSA: ELA, Math and Science in April.
- 8th graders will take the PSSA: ELA, Math and Science in April.
- 9<sup>th</sup> graders will take the Algebra 1 Keystone in May.

#### Homework

Homework is a positive reinforcement of learned skills as well as a building block toward student responsibility. Parental support and cooperation is a vital component in ensuring its effectiveness. Every teacher will provide homework as part of the students' personalized learning plan.

Please keep in mind these key points:

- Students should communicate and voice any questions or concerns regarding the work.
- Teachers will assign homework and projects and will provide additional support as needed.
- Parents/Guardians should provide a quiet spot for students to do their schoolwork and to teach the student how to balance extracurricular activities.

## **Parent Meetings**

Families can request a meeting with Crossroads Staff. Meetings can be scheduled in person or virtual. Meetings will take place on an individual, as needed basis.

## Make up Work

All students who miss class for any reason are required to make up work they missed.

Students have two days upon returning to meet with teachers to receive missed work. All make up work must be returned within 1 week of pick-up.

Students may meet with teachers at the beginning, end of the day or by special appointment, not during class time.

Students with excused absences (notes) may make up work for full credit. Unexcused absences may make up work for half credit (50 percentage points).

Tests, Quizzes, and Projects are subject to special regulations; see your teacher for details.

## **Plagiarism**

The consequences for cheating and plagiarism and cheating can be very serious and can lead up to and include expulsion.

#### **Health and Welfare**

Students should attend school **ONLY** when they are well enough to participate in all regular classes. There are, however, exceptions such as broken bones, post-surgery, etc. Fever and vomiting should have subsided for at least 24 hours to prevent the spread of infection.

The school nurse has outlined the following general rules on illness and absences:

- ♦ **COVID19** Contact the school Nurse
- ♦ Streptococcal Infections (strep throat, scarlet fever, tonsillitis): Excluded for 7 days unless a physician certifies recovery in a shorter amount of time.
- ♦ <u>Pink Eye</u>: Excluded and can only be readmitted to school with a physician's certificate of **COMPLETE RECOVERY**.
- ♦ <u>Impetigo</u>: Excluded until judged noninfectious by the school nurse or physician.
- ♦ <u>Pediculosis (Head Lice)</u>: Excluded until judged noninfectious by the school nurse (no nits). Special attention for prevention includes: not sharing combs, hats or other clothing. Head lice are most prevalent immediately after the holidays. Treatment as per your physician or consult the school nurse.
- ♦ **Scabies**: Excluded until judged noninfectious by a physician or school nurse.

Please remember that the school nurse is not permitted to diagnose illness or injuries. **DO NOT** send your child to school with this expectation. Injuries occurring at home cannot be dressed or retreated by school personnel.

We prefer medications not be sent to school, unless a time schedule cannot possibly be made around school hours Any medication to be given in school **MUST** be accompanied by a note from the doctor with specific instructions for administration. **DO NOT** send your child in with the prescription medicine. A parent **MUST** bring it to the Crossroads Main Office to check it in. Over the counter medication cannot be dispensed without a signed doctor's MED-1 form.

## **Emergency Closing of Schools**

If school is closed for the day or closing early for inclement weather or any other emergency there will be an announcement on KYW or any news station and School District of Philadelphia page stating "All Philadelphia Public Schools are closed" or "All Philadelphia Public Schools will have a two hour delay." If there is a two-hour delay students must arrive by 10:00 am.

#### **Promotion and Graduation**

Every student that attends high school within the Philadelphia School District must accumulate a total of 23.5 credits to graduate from high school. Credits are earned by passing classes and will allow students to be promoted to the next grade level. The following are the promotion requirements (moving to the next grade level):

**9th Grade:** Students must have a total of *5 credits* to be promoted to the 10th by September 2023.

10th Grade: Students must have a total of 11 credits to be promoted to the 11th grade by

September 2023.

11th Grade: Students must have a total of 17.5 credits to be promoted to the 12th grade by

September 2023.

**12th Grade:** Students must have **23.5 credits to graduate** in June of 2024.

Students must earn the following credits in each content area and complete the Senior Project in order to graduate:

#### **Credit Recovery**

Anything less than a 60 as the final grade in a class will result in no credit earned, which may cause your child to have to participate in summer school in order to make up missed credits.

## **Internet Usage Policy**

This Internet Usage Policy applies to all students of Crossroads Accelerated Academy who have access to computers. The Internet is used solely for completing school assignments. Use of the Internet by students at Crossroads is permitted and encouraged to support the goals and objectives of the Iready program and classroom assignments. However, access to the Internet is a privilege and all students must adhere to the policies concerning computer, email and Internet usage. Violation of these policies could result in disciplinary and/or legal action leading up to and including expulsion of the student. All students are required to acknowledge receipt and confirm that they have understood and agree to abide by the following rules:

Students are expected to use the Internet responsibly and productively. Internet access is limited to school-related activities assigned by the specific instructor on that specific day for that specific class period. Personal use of computers is not permitted. You may not:

#### **Student Responsibilities:**

The student will share in the responsibility to maintain or improve his/her academic achievement and achieve high personal standards and conduct his/her self in the appropriate manner every day in school and in the community. Specifically the student will:

- Complete assignments and projects in a timely manner and ask for help when needed
