



Why Plan for an Aging Population?

An Aging Nation Projected Number of Children and Older Adults

> For the First Time in U.S. History Older Adults Are Projected to Outnumber Children by 2035



The number of people over the age of 65 is projected to outnumber children under 18 by 2035 nationwide.

The number of people over 65 is expected to double between 2000 and 2030.



Planning for Age and Dementia Friendly Communities:

- Raises awareness about barriers that some older adults and people with disabilities face that prevents them from fully participating in the community
- Builds understanding and acceptance of people facing cognitive decline or who are diagnosed with dementia
- Create a Roadmap for Change Action Plan with projects to implement, and recommendations that can be incorporated into other planning documents


Domains of an Age & Dementia Friendly Community



Public Safety



8% of survey respondents reported times when they did not feel safe in their community



Reasons for feeling unsafe included:

RESPONSES

Just when you hear news about local home invasions, robberies, etc

Main Street, political rallies; I believe the news of the world contributes to the unsettling

Police

Street: State street- bad experience, Colonial Village- mean, rude, frightening men

No sidewalks or streetlights

I live on a main road but there's woods across from me. People like to pull over and sit there in their cars frequently

Not enough side walks, many dark roads unlit.

Downtown area not enough to want v to stay for. Rural areas too much upkeep as you age

Walking on road after dark.

Public Safety Assets

- Police Department and COA partnership, Seniors and Law
 Enforcement Together (S.A.L.T) sponsor:
 - SAND for Seniors
 - Monson Fire & Emergency Services Department will deliver one 5-gallon bucket of sand and refills for free
 - Smoke and Carbon Monoxide Detector installation for free by Fire Department
 - Can get one free Carbon Monoxide Detector per senior household in town
- Newly implemented Senior S.A.F.E program (Senior Awareness of Fire Education)


Health and Community Services

- Support for families and caregivers of people with dementia




How would you rate your overall physical health?

How would you rate your overall emotional well-being?




 52% of survey respondents said their physical health was less than very good

64% of survey respondents reported that their emotional well-being was very good or excellent Do you or someone you care for have any of the following resulting in the need for caregiver services? (check all that apply)


Answered: 70 Skipped: 27




9% of respondents reported needing help but not being able to find it in regard to finding a PCP, getting medical services at home, and finding a mental health service provider Multiple respondents were concerned about affording or had to skip these services due to financial constraint




- 16% of respondents have an impairment or condition that limits their ability to participate in the community
- 24% reported needing help with basic tasks or errands

 Several respondents need help finding help for personal services (basic housekeeping, yard work, or snow shoveling)






Out of the 20 respondents who identified as a caregiver, only 2 reported having access to all the information on caregiving that they needed, and only 1 person reported access to a support group


Are you a caregiver for any of the people you live with?

Answered: 19 Skipped: 78




Dementia Awareness



 5 respondents (5.5%) need help coping with forgetfulness or confusion, but don't know where to access help


Do you (yourself) need help coping with:
