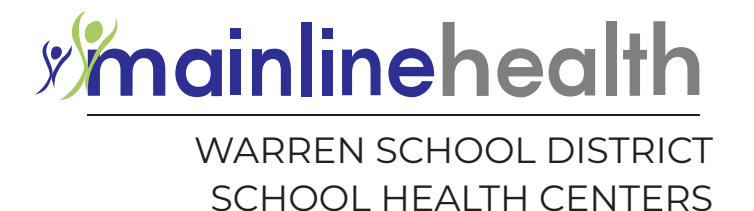

BEHAVIORAL HEALTH

Behavioral Health (BH) Services require a REFERRAL, and it must be a scheduled appointment.

(BH services ONLY available for students and staff)

For the first BH appointment (intake) a parent/guardian **MUST** be present. There may be other specific forms, screeners, etc. that will need to be filled out prior to the visit.

PLEASE ALLOW AT LEAST 1.5 HOURS FOR THE INTAKE

BEHAVIORAL HEALTH/MEDICATION MANAGEMENT

Medication management services are available to support students with mental health needs and are incorporated in the behavioral health care plan at the parent/guardians discretion. The nurse practitioner works closely with the therapist to ensure that students receive appropriate medications and monitoring to enhance their well-being and academic performance.

BEHAVIORAL HEALTH/ MEDICATION MANAGEMENT

**Medication changes will NOT be made without
parent/guardian consent.**

We accept ALL health insurances including Medicaid, Medicare, and private health insurance.

You **ARE** responsible for any **co-pay, coinsurance, deductible**, etc. We accept cash and credit card payments. If you or your child do not have health insurance, we offer a **sliding fee** that is income-based to cover services.
