Same exposure, different vulnerability



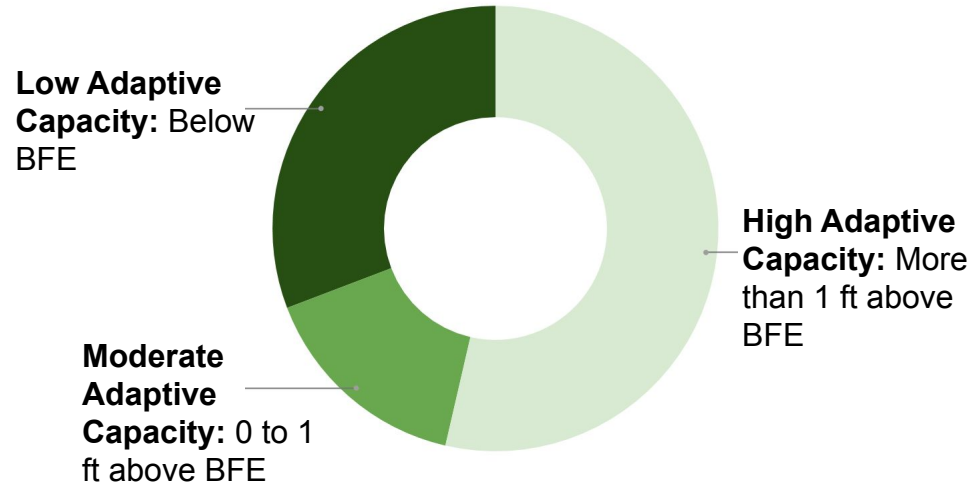
# Physical Vulnerabilities: Assessment Criteria

City-specific factors that are used to define what makes community assets highly vulnerable and at risk to the hazard:

- Review rulesets - if a community asset is vulnerable, what contributes to its high vulnerability?

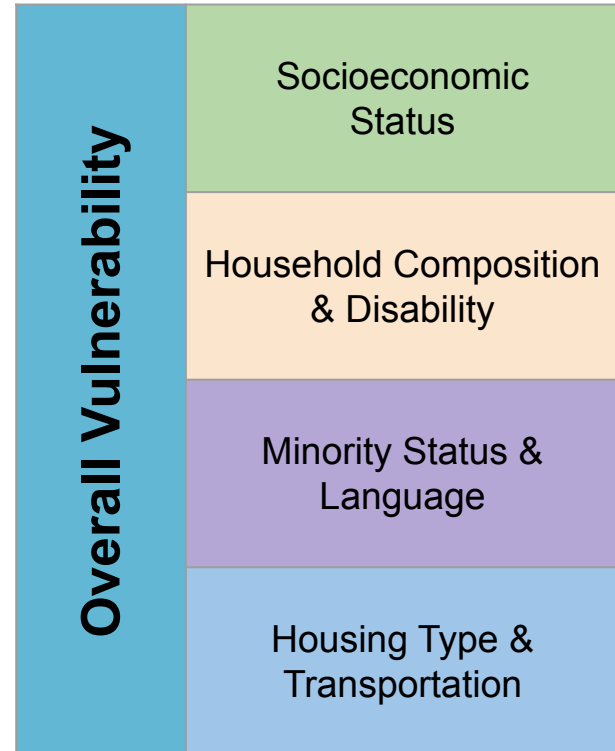
The example at right shows the adaptive capacity criteria for properties prone to floodplain inundation city-wide.

# Social Vulnerabilities: Key Consideration

- Vulnerable populations are disproportionately affected by hazard events
- Both impacts to sensitive populations and to critical services (i.e. food retailers) need to be considered
- Several types of information are used to understand multiple aspects of social vulnerability:
  - CDC's Social Vulnerability Index (SVI) and related metrics using Census data
  - Critical community assets (community centers, SNAP retailers, public housing)
  - Understanding from community input and past experiences
