What's the difference?

Dual Credit	Advanced Placement (AP)
Curriculum designed by HCC, Course may be taught by a Katy ISD teacher or HCC professor	Curriculum designed by College Board, Course taught by a Katy ISD teacher

Cost Savings:

Cost at HCC: \$550/3-hour course plus fees and textbooks

Cost in Katy ISD: \$65/course plus textbook (2023-2023 school year)

Save Time:

Credit Policies

Academic credit is transferable to public colleges/universities in Texas either as core or elective credit

May or may not be accepted by out-of-state or private institutions

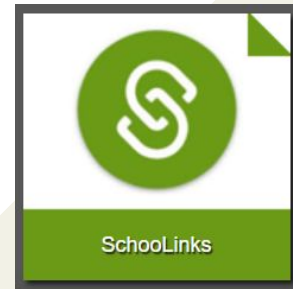

- I understand that the student must have written permission from the high school counselor before he/she can withdraw from a dual credit course.
- I understand that Academic Freedom allows faculty and students to pursue relevant course content that may be adult in nature.
- I understand that once the student is registered in a college course, he/she controls access to his or her educational records under the Family Educational Rights and Privacy Act (FERPA) and—unless an exception applies—I may not have access to my student's records without his/her written permission or proof that I claimed the student as a dependent on my most recent income tax return.
- I understand that a college level standard of conduct is required. It is my responsibility to comply with the admission policies, student code of conduct, policies, academic standards of HCC, and standards set forth in the course syllabus.
- I acknowledge that I have read the Student Commitment Statement and understand that I can only succeed through hard work and will take the initiative in my education.

Important Updates

Students *new* to Dual Credit will need to submit two things to HCC:

- Waiver form - The waiver allows HCC to apply a DC tuition waiver to the students' account.
- The Residency form - This form allows HCC to edit student information in the event it was entered incorrectly in ApplyTexas

Returning students do not need to submit anything EXCEPT the CAMPUS' ONLINE REGISTRATION

Government Online Requirement

State law requires that dual credit courses offered in partnership with an institute of higher education must cover the Texas Essential Knowledge and Skills (TEKS). The dual credit US Government course offered by HCC does not include TEKS on state and local government. In order for students to receive high school credit for the dual credit government course students must also complete an online component in Canvas on state and local government.

- This online component is completed on a pass/fail basis.
- Campuses can require that students complete the Canvas online course:
 - In the opening days of the Katy ISD semester prior to the start of HCC classes,
 - During the course of the semester, or
 - After the completion of the HCC semester but before the end of the Katy ISD semester.

Students who take dual credit US Government in summer school must also document completion before receiving high school credit for the course. High School Social Studies Instructional Coaches have been provided with training on the management of the Canvas course.

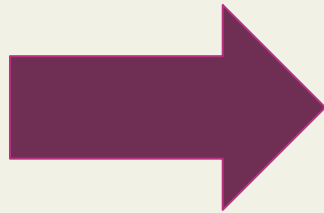

TSIA being offered at Katy High School is for students interested in Dual Credit and Seniors preparing for college-level courses. Before registering for the assessment, please read the information below, so you are prepared for your upcoming test date(s).

REMINDERS!

- Check your personal email, the one used to register for the TSIA, for instructions on how to complete the mandatory Pre-Assessment Activity (PAA).
- Room location will not be known to student in advance but location will be emailed on the day of the test.

Frequently Asked Questions

ONCE I COMPLETE THE PAA, WHAT DO I NEED TO DO?	You will be required to provide a physical, printed copy of the Certificate of Completion, on the day of the test.
WHERE WILL THE TSIA BE HELD?	It is the student's responsibility to check their personal student email for additional instructions, to include, how to complete the PAA, and room location, closer to the test date.

 - Student will be required to provide a physical, printed copy of the PAA's Certificate of Completion, on the day of the test.
- **Can I practice/study for the TSIA2?**
 - KHS students taking the TSIA2 on-campus will receive a confirmation email, to the email address used on the registration form, with recommended study material.

THE PLACEMENT TESTS

TSI ELAR Test

- There are 30-78 questions on this test.
- Subject matter includes:
 - Literary Text Analysis, Informational Text Analysis and Synthesis items, Essay Revision and Editing, Sentence Revision, Editing, and Completion items.

TSI Writing Test

- A 300-600 word essay.

TSI Math Test

- There are 20-68 multiple-choice questions on this test.
- Subject matter includes:
 - Quantitative Reasoning, Algebraic Reasoning, Geometric and Spatial Reasoning and Probabilistic and Statistical Reasoning.

Student Registration

ApplyTexas Application

- ❑ applytexas.org
- ❑ Typically takes 24-48 hours for students to get HCC information after applying
- ❑ Students who are returning DO NOT have to apply using ApplyTexas again. They already have their needed information.
- ❑ Required for new HCC students only.
- ❑ Reminder: If student is enrolling in a summer DC course, they do not need to complete a separate ApplyTexas application.

HCC Policies

Bacterial Meningitis

Future and returning students who are under the age of 22 and plan to enroll in one of the course options below will be required to provide proof of meningitis or qualifying exemptions prior to enrollment.

Vaccination

- In-person
- Hybrid
- Hybrid Lab

Students enrolled in one of the following [course options](#) will automatically be exempt from the meningitis vaccination requirement.

- Online anytime
- Online on a schedule
- Dual-credit students attending a high school location

FERPA

FERPA affords students in “attendance” at Houston Community College certain rights with respect to their education records.

WHAT DOES ETV DO?

Eligible students can receive up to \$5,000.00 per school year to pay for housing, utilities, tuition & fees, vocational training, childcare, books & supplies.



WHO'S ELIGIBLE?

- Youth who is 16 years of age and still in foster care
- Young adults under 23 who have aged out of foster care, are in extended foster care
- Youth that was adopted after turning 16
- Youth under the custody of the Tx. Juvenile Probation Commission
- Unaccompanied Refugee Minors
