This dataset, created and maintained by The Fully Informed Jury Association, covers in-person, criminal trials by jury in the U.S. District Courts and courts in the fifty states. The most recent updates were made on 11 December 2020. As part of FIJA's educational mission, this dataset is made available freely for public use. Data has been collected for all of the U.S. District courts, as well as from statewide orders imposed by the judicial branch of each state. Many states are not currently imposing statewide suspensions, but individual, local courts in those states are generally free to impose local suspensions of trial by jury in criminal cases.

The "Suspended Until AT LEAST" date is the earliest date that in-person, criminal trials by jury will generally be permitted in the corresponding court or court system. In many of these courts, the suspension is on new trials, with those currently in progress being allowed to proceed to completion. A few of the courts on these sheets with a "Suspended Until AT LEAST" date may allow either virtual trials by jury or exceptions made for extreme necessity on a case-by-case basis for in-person trials by jury in criminal cases, but otherwise criminal trials by jury are generally suspended in that jurisdiction.

The sheer number of local courts puts the task of an exhaustive inventory of all such orders outside of FIJA's capabilities with our limited budget and staff. However, we are recording information for indvidual courts as we see them crop up in the news. We are periodically reviewing the websites of the federal courts and the state judicial branches, with the most recent updates to those tabs being made on 9 December 2020. No similarly comprehensive review for these individual courts would be practical for FIJA to conduct with our limited resources. Each of these entries contains a corresponding "Date Last Checked" so that you can determine how current that piece of data is before you use it. If you find more current data, we would appreciate it if you would let us know with an email containing a link to documentation of the needed update to aji@fija.org so that we may update it.
