The children also reported having to kneel on seats as punishment, as well as frequent beatings with objects including, "including pony bottles, belts and wooden boards." Officials at Texas Children's Hospital concluded that the boys were malnourished and were suffering from "physical abuse, and psychological abuse and neglect."

Doctors discovered the child had sustained a spiral fracture while a full body x-ray revealed multiple injuries to both the child's arms and legs at various stages of healing. The child also appeared to have sustained a clavicle fracture at some point in time, and had bruising around both eyes. Dr. Joseph Hagan, a doctor at the hospital who specializes in abuse cases reportedly told officials this was one of the most severe cases of abuse he'd ever seen. Court records contradicted that, according to WWBT, showing that the 1-year-old had bruises on his forehead from banging his head on the door of the gate.

"The problem is in the case law. Unless we can show that the neglect was intentionally set about to cause physical harm or kill the children or was so gross and reckless, the courts repeatedly hold that just being a bad parent and keeping a messy, dirty house is not enough to convict somebody of felony child neglect. It's got to be worse than that."
